Introduction

This document details the 2025 CDP Cities Scoring Methodology and should be used in conjunction with the CDP Cities Questionnaire & Reporting Guidance for 2025 as well as the Cities Scoring Introduction and other scoring documentation. It is strongly recommended to familiarize yourself with the contents of both the 2025 guidance and the CDP Cities Questionnaire before using the scoring methodology. Question dependencies will be detailed in these supplementary documents to inform disclosers which questions they are eligible to be scored for.

This document provides the scoring criteria and points available for each question in CDPs 2025 Cities Questionnaire.

In common with other scoring processes of this type, we expect to make future adjustments, during the disclosure cycle, to optimize the clarity of the scoring methodology in context of responses received.
